For themselves, their principals, representatives, employees and agents: 1. Shall be subject to the constitution and rules of the competition; 2. Represent that every horse, rider, driver, and handler is eligible as entered; 3. Agree to hold the competition, their officials, directors and employees for any action taken; 4. Agree that as a condition of and in consideration of acceptance of entry, they authorize the competition management to market, transfer, assign or otherwise make use of any photographs, likenesses, film, broadcasts, cablecasts, audiotapes or videotapes taken of the horse(s) and participant(s) while on the grounds, incident, to or in transit between the stabling facility and the event site. In any way they see fit for the promotion, coverage or benefit of the event, without compensation to any of them, so long as the use neither jeopardizes amateur status nor endorses a specific product or service and to invasion of privacy, right of publicity or to misappropriation, and 5. Agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk or serious injury or death and by participating they expressly assume any and all risks of injury or loss and they agree to indemnify and hold the competition and their officials, directors, employees and agents harmless from and against all claims including for any injury or loss suffered during or in connection with the competition whether or not such claim, injury or loss resulted directly from the negligent acts or omissions or indirectly from the negligent acts or omissions of said officials, directors, employees or agents of competition.
