Shavings/Stall Reservations: Shavings may be ordered in advance when placing stall reservations. All stall fees must be sent in to guarantee stall reservations. All stalls must be paid in advance. Stall fee is non-refundable, no exceptions. Please be sure to include your email address below, so that we can send you an email confirmation that we have received your stall reservations.

HEALTH REQUIREMENTS FOR THE ENTRY OF HORSES/PONIES ON FACILITY

Florida regulations require that all equines covered by official interstate health certificates, issued by a licensed veterinarian, showing that the animals are free from any symptoms of any infectious or communicable disease. The certificate shall include the name of the owner and address, destination in Florida, number of horses examined, the name, registration number(s), if any, sex, age, rectal temperature, color, and markings of each animal listed. Health certificates will become void after 30 days of issue. Health certificates must show animals to be negative to an equine infectious anemia test within the past 12 months. Date of test and approved laboratory must be shown on health certificate. Equine Rhinopneumonitis vaccination is not required; however, if any animal is vaccinated, it is ineligible for entry within 21 days of vaccination. Vehicles transporting animals must have certificates showing it was cleaned and disinfected under veterinary supervision prior to loading. This information can be written on the health certificate.
